# Corporate Information

- Superkrane is a **leading** heavy equipment rental company in **Indonesia**, operating a fleet of **over 600 units** and focusing on sectors such as construction, infrastructure, petrochemicals, etc.

## Fleet Composition

Total 678 units of heavy equipment, actively utilized by clients across multiple sectors. In 2025, 21 new units were added to the fleet, including crawler cranes, forklifts, light vehicles, manlifts, and mobile cranes.

## Project Portfolio

Currently managing 35 active projects spread across 16 provinces in Indonesia, supported by a dedicated workforce of 698 personnel.











**Revenue (IDR Billion)**



**Gross Profit (IDR Billion)**




**Net Profit (IDR Billion)**
